#### Hi Paul and Ben:

In anticipation of discussing this further next week, I pulled some info re: SCSB membership composition – please see the attached file. For reference: the operative statute is [CGS 4e-2] for the board – the appointive officers statute for members is [CGS 4-1a]; for executive director is [CGS 4-7].

As far as member terms - [CGS 4e-2] states the following:

(c) The chairperson of the board shall be appointed by the Governor. The terms of the members shall be coterminous with the terms of the appointing authority for each member and subject to the provisions of section 4-1a. If any vacancy occurs on the board, the appointing authority having the power to make the appointment under the provisions of this section shall appoint a person in accordance with the provisions of this section.

Per the <u>SCSB website</u>: here is a table that depicts who has been appointed, by which appointing authorities. Unless I'm misunderstanding something – which is possible – we may have the opportunity to appoint as many new members in Governor's seats as we deem necessary, due to all of them being appointed by the previous administration.
