GUARDIAN AD LITEM'S PROPOSED ORDERS

The undersigned Guardian Ad Litem hereby files her written Proposed Orders to the pending custody and visitation trial:

1. A judgment of custody and visitation shall enter.
2. A judgment of parentage shall enter.
3. The Applicant Mother shall have sole legal custody of the parties' minor child, .
4. Due to the criminal protective order that was issued by Court (Stango, J) on July 12, 2024, the Respondent Father shall not have any visitation and/or contact with the minor child until such time as the criminal protective order is terminated and/or modified that access would be permissible.
5. The minor child shall continue to be engaged in individual counseling and neither parent shall be permitted to discharge the minor from her treatment unless recommended by her clinician. All parties shall follow all recommendations set forth by the minor child's clinician.
6. Neither parent shall make any disparaging comments about the other parent or the extended members of the other parents' family in front of .
7. The Applicant shall confirm that all herbal supplements, vitamins, and over-counter

medication that is in her residence is properly secured in a lock box and out of the reach out the minor child.

8. If either party is desirous of filing a post-judgment Motion for Modification with the Court, they shall follow the requirements set forth in Section 25-26(g) of the Connecticut Practice Book.
9. If the Court grants a Request for Leave filed by the Respondent, the Respondent shall confirm that he has undergone the following prior to his Motion for Modification-Post Judgment being filed and heard by the Court:
 - A. The Respondent is to undergo a hair follicle test to confirm that he is negative for all illicit substances and that the only substances that he is testing positive for are under the direction of his treating physician. The Respondent shall utilize the services of Paymer & Associates to undergo the hair follicle test. The hair follicle panel test selected shall also test for the presence of anabolic steroids. Copies of the results shall be released to the Applicant's counsel and/or Family Relations Office.
 - B. The Respondent shall undergo a psychological evaluation. The Respondent shall follow all recommendations set forth by the selected evaluator including but not limited to individual counseling and medication management. The forensic psychologist selected by the Respondent shall be off the ABH approved list. Copies of his evaluation shall be released to the Applicant's Counsel and/or Family Relations Office.

C. The Respondent shall undergo a full neurological examination including but not limited to MRI testing to rule out that the Respondent is suffering from an underlying medical condition that has caused to present with delusional thoughts. Copies of the results shall be released to the Applicant's counsel and/or Family Relations Office.

10. The appointment of the Guardian Ad Litem shall be terminated. The Guardian Ad Litem shall have thirty days to submit her final invoice to the parties for payment.
