On 2/22/24, I (Det. Jackson) called Attorney Cindy Robinson (2 [REDACTED]) of Robinson Mahoney At Law, 1210 Post Road, Fairfield CT. Attorney Robinson represented Alexandra Standish after she suffered injuries in a motor vehicle accident. When I spoke to Attorney Robinson, I told her that I've heard Alexandra was awarded anywhere between \$933,000.00 and 1.9 million dollars. I explained a little of what happened with Alexandra's suspicious death. I asked if she could tell me the exact amount Alexandra was awarded, so we would have an idea of how much money might have been involved in her death. Attorney Robinson couldn't discuss the amount, because of attorney client privileges and because there was a nondisclosure agreement with the lawsuit. Attorney Robinson said she will speak to Alexandra's dad, Scott Standish, who can discuss the amount. She said that she will ask him to call me.

The accident Alexandra Standish had was on 3/2/17, in New Britain, CT. (New Britain police CN 17-4211). The jaws of life were used to extricate Alexandra after her Honda Civic was hit by an oil truck. She suffered numerous broken bones in the accident.

On 2/27/24, Scott Standish ([REDACTED]) called me. He said in 2021, Alexandra was awarded 1.9 million dollars. \$300,000.00 then went towards attorney fees. She received 1.6 million dollars. Alexandra bought her house in Wolcott for \$320,000.00 cash. She spent \$60,000.00 for two vehicles. She also bought a couple of motorcycles. He said he wasn't sure where some of the money went. Alexandra invested some with a friend of Scott's named Jim Wallace. Scott believes Alexandra now has \$684,000.00 in her investment account. Scott said Jim Wallace worked at Newtown Savings Bank, where Alexandra originally put her investments. Jim then opened his own business in Newtown, CT., called Steward Partners Global Advisory. Alexandra then transferred her money there. Scott said on 10/23/23, Alexandra and Brandon met with Jim. Alexandra changed the beneficiary on her investment account, to 100% for Brandon Hamel, but didn't say why.

On 2/27/24, at 11:45 a.m., I spoke to Jim Wallace ([REDACTED]) of Steward Partners Global Advisory, 32 Church Hill Road, Unit 107, Newtown, CT. The phone call was recorded on my body camera.

Jim told me that Alexandra has \$653,000.00 in her account. He said the assets are currently invested at Raymond James.

At the end of October 2023, Alexandra Standish and her boyfriend, Brandon Hamel came to Jim's office and changed the beneficiary on her account. Jim said the account originally had 50% for Alexandra's mom and 50% for Brandon Hamel, but Alexandra changed it to 100% for Brandon Hamel.

On Monday, 2/12/24, at 8:30 a.m. (2 days after Alexandra's death) Brandon called Jim and told him Alexandra was hit by a car and passed away. Brandon said he was the one that found her. Brandon asked what he needed to do to get the money from the account. Brandon was told that he needs a death certificate. Jim explained that if Brandon gets a death certificate, he could receive the money just a couple days afterwards. I asked if during the police investigation, if he could put a hold on any money being paid out. Jim said that he was calling the company to attempt to stop any payments and may need something from court. I asked Jim to call me if something is needed from court, to stop payment.

Jim works by appointments. On 2/20/24, at a few minutes before 11:00 a.m. Jim remembers the time, because he had an 11:00 a.m., appointment. Brandon and a friend, who Brandon called a brother, showed up unexpectedly at Jim's office. Jim met the men in the front lobby and believes the guy with Brandon was named Ed. Jim said Ed had a beard and tattoos on his left hand.

Jim said Alexandra would sometimes withdraw money from her account. Alexandra's last withdraws were on 12/15/23, when she withdrew \$9,000.00. On 12/19/23, she withdrew \$6,000.00 and on 1/5/24, she withdrew \$10,000.00 (\$25,000.00 in 22 days). Jim said it was several

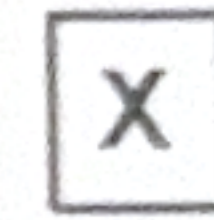
