ejected from the motorcycle and transported to St. Mary's Hospital with suspected life threatening injuries and later to St. Francis Hospital.

I contacted St. Francis Hospital and spoke with a nurse in ICU. The nurse reported that B. Hamel was transported there and was currently under going surgery for a broken pelvis. It's was also reported B. Hamel sustained serious injuries to his legs, arms, wrists and other body parts. At this time they were unsure of his statutes.

As of Friday 03/01/2024, B. Hamel is still hospitalized and will be at St. Francis for sometime with several more operations scheduled.
