On Thursday 04/11/2024, Scott Standish 03/08/1954, came into the Wolcott Police Department to file a fraud complaint. Scott, who is power of attorney over his deceased daughter's estate stated he received a credit card statement from Capital One, Cabela's Club card ending in [REDACTED]. The statement was mailed to Alexandra Standish at 129 Central Avenue, Wolcott, Ct. 06716-3025, and shows a billing cycle of 03/03/2024, thru 04/02/2024. Scott further explained that the account was issued to his daughter Alexandra Standish 07/26/1986, and Brandon Hamel 08/24/1987, was an authorized user on the account. The statement shows the credit card issued to Alexandra ends with the last four digits of [REDACTED], and the credit card issued to Hamel ends with the last four digits of [REDACTED]. It should be noted Alexandra died as a result of being run over, in her own driveway on 02/10/2024. Hamel was implicated and a valid arrest warrant has been issued for him. Hamel will be arrested and charged in her death once released from Gaylord Rehab Hospital.

This statement shows that on March 04, 2024, a purchase was made from SP Integrated Engine out of Salt Lake City, Ut., in the amount of \$637.04, using Hamel's credit card ending in [REDACTED]. It should be noted that on Tuesday 02/26/2024, Hamel was involved in a motorcycle accident on interstate 84 westbound in the town of Cheshire, where he sustained life threatening injuries. eventually transported to St. Francis Hospital, where he was being treated in the Intensive Care Unit for a traumatic brain injury and other serious life threatening injuries which include two broken femurs and broken pelvis. Hamel was transferred to Gaylord Rehab Hospital in Wallingford, Ct. at the end of March 2024. Scott believes Hamel's friend, Edward Pratte 12/27/1982, made this purchase. Scott stated he called Integrated Engineering and was told the item(s) purchased were for an Audi automobile. That Integrated staff would not give him any further information in regards to this purchase.

I contacted Integrated Engineering via phone # [REDACTED], and spoke with sales associate Aldin K. Aldin explained the products purchased are software upgrades to boost a vehicles engine and transmission performance. That once a purchase is made the software is downloaded directly to a specific vehicle by using the Vehicle Identification Number or VIN. On the date in question there two orders placed and assigned order numbers 1400071888 and 1400071898. Order number ending in 71888 was used to purchase the following software-IE VW & Audi 2.0T TSI Gen 3 IS38 MQB Performance ECU Tune. Order number ending in 17898 was used to purchase the following software-IE Tuning Credits/Upgrade Stages. The software purchased was downloaded and used to tune a 2018 Audi S3 with VIN [REDACTED]. Aldin stated the purchases were made under the name Edward Pratte, email contact, [REDACTED] using Mastercard ending in [REDACTED], in the total amount of \$637.04. The billing was addressed to Brandon Hamel, 129 Central Avenue, Wolcott, Ct. 06716, phone [REDACTED]. An N.C.I.C./COLLECT check of [REDACTED] revealed the vehicle is a 2018 Audi S3 Premium, color white bearing Ct. registration [REDACTED], and registered to Amanda Pratte 09/28/1985, out of [REDACTED].

I later received an email from Aldin K, which showed another order was placed under the name Edward Pratte, email contact, [REDACTED] using Mastercard ending in [REDACTED] and assigned order number 1400070990. This order showed the billing was addressed to Edward Pratte, 69 McKenzie Drive, Southington, Ct. 06489, phone # [REDACTED]. That this purchase was canceled and refunded to the Mastercard ending in [REDACTED].

While investigating the death of Alexandra the following was learned. Alexandra had \$653,000.00 in an investment account held by Steward Partners Global Advisory and life insurance policy through TransAmerica Life Insurance. The life insurance policy was for \$50,000.00 with a \$50,000.00 accidental rider, totaling \$100,000.00 for Alexandra. That Hamel was made sole beneficiary on both accounts back in October of 2023. That two days after Alexandra's death Hamel contacted Steward Partners Global advisory and TransAmerica Life and wanted to know how to collect the money from the accounts. On 02/20/2024, Hamel and Edward Pratte who he called a brother, showed up unexpectedly at the office of Jim Wallace, who handled Alexandra's investment account. Wallace met the men in the front lobby. Wallace said the two were inquiring on how to collect the money from Standish's account. Wallace explained they would need a death certificated in order to collect any money.

On Thursday 03/07/2024, Jim Wallace called Detective Jackson and stated Edward Pratte showed up at his office with a State of Ct.

Certificate of Death. Wallace stated he had concerns the Certificate of Death was a fake and didn't look authentic. Wallace stated the Certificate of Death did not contain Standish's social security number and listed the manner of death as Pending Investigation. Wallace e-mailed a copy of it to Detective Jackson. It should be noted that Eddie Pratte is not related to Hamel or Standish and has no legal right to either the investment account or insurance policy.

That, on Friday 03/15/2024, Wallace contacted Det. Jackson via e-mail in regards to Edward Pratte dropping of a Durable Power of Attorney, naming Edward Pratte power of attorney over Hamel's financial accounts but not health care. Wallace e-mailed a copy of the Durable Power of Attorney to Det. Jackson. The Durable Power of Attorney is dated 3-14-24 and separated into eight (8) sections. 1. Appointment of my Agent, 2. Effectiveness, 3. Agent of Fiduciary, 4. General Authority To Act, 5. Specific Acts Authorized, 6. Amplifying Powers, 7. General Provisions, and 8. Special Instructions (Optional). Section 4, subsections a.-o. are required to be initialed by B. Hamel and show BH initials for each corresponding subsections. Section 5, subsections a.-o. are required to be initialed by B. Hamel and show BH initials for each corresponding subsections. At the end of section 8. Special Instructions (Optional) requires B. Hamel's signature. It should be noted the signature on this document does not match B. Hamel's signature from in house arrest paperwork obtained by the Wolcott Police Department on 02/08/2024. The SSN or TIN line shows the last four digits of B. Hamel's social security number as [REDACTED]. The last four digits of B. Hamel's social security number are [REDACTED], which have been confirmed by state records. The phone number [REDACTED], is listed to Pratte. The Notary Acknowledgment section of the document shows it was notarized by a Lisa D'Amato, in the county of Hartford, on 3/14/2024, and her commission expires 12/31/2027. The Statement of Witness section shows the First Witness as a Brian Zukowski with his

On Friday 06/14/2024, I contacted the Meriden Police Department in regards to Edward Pratte 12/27/1982, who this agency held an active arrest warrant for. A warrant was submitted to the Waterbury Superior Court charging Pratte with Illegal Use of a Payment Card, in violation of C.G.S. 53a-128d\*, Payment Card Fraud, in violation of C.G.S. 53a-128c(d), and Larceny 5th Degree, in violation of C.G.S. 53a-125a. The warrant was signed by Superior Court Judge Kwak on 05/10/2024, with a \$5,000.00 court set bond.
